Introduction - Preface

The process of editing and publication of the proceedings for the 5th Interdisciplinary Congress on

"Education, Research, Technology. From yesterday till tomorrow" organized by N.T.U.A. and M.I.R.C. of the N.T.U.A. has taken longer than expected for very specific financial reasons due to which the grant promised by the Ministry of Environment was cancelled.

Following these facts we decided to upload on the M.I.R.C. site (http://www.ntua.gr/MIRC/) the:

- Opening session, proceedings
- Keynote speech
- Complete texts of papers presented at the conference
- Round-table and closure discussion

The publication of the conference proceedings was finally concluded by M.I.R.C. of the N.T.U.A. due to the generous scientific and technical support of the N.T.U.A. Metsovion Interdisciplinary Research Center (M.I.R.C.), M.I.R.C. Development Foundation and the Laboratory of Remote Sensing, the Cadastre Research Foundation and the financial support of National Technical University of Athens, on all levels.

The 5th Congress took place in the N.T.U.A. – M.I.R.C. premises in Metsovo on 27-30 September 2007 and was dedicated to the subject "Education, Research, Technology. From yesterday till tomorrow".

This congress was planned in the framework of the N.T.U.A. institution involving among others triennial Interdisciplinary Interuniversity Conferences focused on protection and development of mountain environment and local European Cultures and stemming from N.T.U.A.'s decision to systematically reinforce its ties to the homeland of its founders and benefactors, as a way of paying back part of N.T.U.A.'s debt to them.

The goal of this conference was to contribute, on both theoretical and practical levels, to the analysis of the potential of multidimensional relations and interactions of Education, Research and Technology with economy, society, politics and culture considered as fundamental contributors to integrated development. This type of development will be worth living for, as it will respect man and his natural and cultural environment in the especially critical conditions of natural and socio – economic situation in the modern world and their dramatic changes.

In the framework of this triennial tradition of conferences of memory, honor and live contribution of the entire N.T.U.A. potential to the integrated interdisciplinary research, study and confrontation of basic factors of development and environment, this conference was organized on a methodology aiming at the following targets:

• to gather the whole community of the National Technical University of Athens as well as the other universities of this country, including their professors, students

- and alumni, encouraging their contribution through individual or collective papers or even thesis and student work on the themes of the conference
- to continue the firm and creative collaboration with the University of Ioannina, involving the priceless initiative of Professors P. Noutsos and E. Kapsomenos towards this common goal and
- to constantly develop and strengthen systematically the necessary prerequisites for a constant communication and collaboration between N.T.U.A., the Prefecture of Ioannina and the Municipality of Metsovo as well as the other institutions of Metsovo and its inhabitants.

The subject matter specially covered in the 5th Congress of N.T.U.A. and M.I.R.C. in Metsovo, includes theoretical contributions as well as specific applications contributing to the development of methods, techniques, software and/or scientific or technological innovations in one or more of the following thematic fields:

- 1. Education, Research and Technology for a peaceful and better world. Goals, values, programs of study, research projects technological innovations, evaluation of results on economic, social cultural, political and environmental levels are included in this field
- 2. Critical evaluation of national and European policies on education, research and technology in globalization era.
- 3. The public character of education. Critical issues. Values, Problems and Proposals.
- 4. Competition, market, work relations and Universities. Can the "Executive University" be considered as a University?
- 5. Education, Research and Technology. Relations, interconnections, interdependencies, boundaries, potential, limitations and perspectives.
- 6. The unified European space of Universities Positive and negative aspects. Can economy considered as "increase" become the main determining factor?
- 7. Education as culture and civilization as compared to its competitive commercial version. Short-term and long term costs and benefits.
- 8. Towards a National Strategy on Education, Research and Technology. Problems, potential, limitations and perspectives.
- 9. Contribution of new technologies to the creation of new products and services useful for man and society, with special emphasis on mountain or island regions as well as on degradated urban areas.
- 10. Development of forms of housing, tourist settlements and energy that are suitable to people, especially in mountain and island regions.

11. Education, Research and Technology for an integrated (economic, social, political, cultural and technical/technological) and decentralized development, in dialectic harmony with the environment.

The papers presented and discussed during this Congress are published in these volumes, reflecting the results of our fifth effort, and they are open for review and criticism by any reader, depending on his background and interests.

These papers treating the subjects of Education, Research and Technology and their multidimensional relations and interconnections with politics, society, civilization, economy, mostly in reference to development and environment issues, can be grouped in the following four entities:

- Interdisciplinary theoretical essays, practices and policies (15 papers)
- Specialized analytical and applied studies (19 papers)
- Papers presented in the framework of the special interdisciplinary conference on the theme "Civilization and Development" which was organized by professor Kapsomenos under the auspices of M.I.R.C., M.I.R.C. Development Foundation, and the University of Ioannina (15 papers)
- Specialized research papers (19 papers)

Introductory remarks: The Nature, Role and Public character of the University in the recent past (1997).

The public University is the focus of this congress and many participants serve and defend this institution, believing that Education and Culture are social assets belonging to all citizens and forming the basis of integrated development at all levels (political, social, cultural, economic and technical/technological), towards the creation of a peaceful and better world.

In 1997, exactly 10 years ago, in the framework of my introductory speech in the fifth Conference of Philosophy in Chania (29-31/8/1997) focusing on the theme: "The University in an emerging society", I tried to answer the question:

"What is the **nature** and **destiny** of the University today and what is the meaning of its **Public Character**?"

And first, what is the meaning of **today**?

- Does this word include not only the "present" of all those who, like us live, work and study in our ivory, glass or paper microcosm, but also the general political, social and economic "present" of our country as an "independent" island of happiness or as a province of Brussels striving towards numismatic convergence?
- Does "today" refer to the actual one-dimensional world of globalization and its dramatic multi-level consequences?

I believe that our approach should refer to all these "presents" together. This means an integrated "today", composed of a superposition of all the independent ones together.

- At global level, this is defined by:
- a new order, dominated by the sole super-power, U.S.A.,

- the neo-liberalism which is finally the dominant ideology on a global level,
- the collapse of the communist states and their effort to be integrated in the capitalist "paradise",
- the social humiliation of the other ex-super power and its partners,
- the absolute dominance of the market, the banks and the stock market and their pitiless competition,
- the on-going homogenization and globalization of civilizations,
- the selective sensibilities of superpowers as to the respect of human rights,
- the generalized multidimensional social economic and political crisis, mercilessly striking at least 1/3 of the citizens of "developed" countries and the majority of developing ones,
- the multiple dominance of the media in the society of markets, information and emerging knowledge.

As a consequence of the above there exists a general direction of substitution of education, as a process of formation of active and responsible citizens, by the mere acquisition of technical / technological dexterities useful to the human machines operating in the global market.

In Greece, "today" is also especially defined by:

- the extreme West-European tendencies of a large majority of the political world, who choose to see the economic and numismatic union as a safe refuge for our country, notwithstanding specific initiatives of many of its members who are far from the theoretical values of the European Union and International Justice.
- the mythical sanctity of the market, the economy, competitiveness and limitless adaptation to all European laws and policies, which emerge not from collective and democratic procedures but from the impersonal bureaucracy of the European Commission.

An inescapable consequence of the above is the increasing disappointment of Greek citizens, working people, university teachers and students and their gradual withdrawal from any creative collective political initiative and activity, which is replaced by growing individualism and exclusively profit persuit.

The **Nature** of the University can be theoretically defined, in a reference to the "nature of things", as "the substance and the whole of its properties" or, even better, as "its deeper and fundamental substance" which is influenced by the members of the university community. We can therefore use the terms "according to nature" or "contrary to nature" to describe rules, habits or behavior of members of the university community, depending on their agreement to the deeper nature and substance of the university.

And if we go back to the emergence, the ideology and the **Purpose** of the University, which are, in theory, "significant work to realize" or even "life dedication" according to the scriptures, we can then investigate, discuss and document their causal relation with the university's public character.

The **Nature** as well as the **Purpose** and the **Public Character of the University today** can be assessed in a different way, depending on their position and point of view, as well as specific interests and ideologies, by the following **groups of interest:**

- Those who live in it and those who stay outside its boundaries,
- the professors, the students and their expressions,
- the "modernist" politicians vs the more traditionally minded ones,
- the European Union, and its competitors, USA and Japan which influence, in several ways, policies concerning universities around the world,
- the average social consciousness which insists in still bestowing a protagonistic role to the university in the evolution of Hellenic social formations.

And what is our particular point of view in this debate? What world do we prefer to keep as is and what would we like to change and how?

This "today" of 1997, our recent past, can contribute, I believe, as a basic introductory remark for the discussions that will follow during our Congress.
